

**Ent Credit Union  
Ent's FoCo Scavenger Hunt Sweepstakes  
Official Rules**

1. **No purchase is necessary to enter or win the Ent's FoCo Scavenger Hunt Sweepstakes.**
2. **Each sweepstakes entry will have an equal chance of winning. One entry per person. One bonus entry per person who completes the riddle on the bottom of the Ent Credit Union Scavenger Hunt game card.**
3. **Sponsor:** Ent Credit Union (Ent) is the sponsor of the sweepstakes. The credit union's business address is 11550 Ent Parkway, Colorado Springs, CO 80921.
4. **Sweepstakes Period:** The sweepstakes begins Monday, September 26, 2022 at 9:00 am MT and runs through Sunday, October 2, 2022 at 11:59 pm MT.
5. **Eligibility:**
  1. Only entrants who turn in their completed and correct Ent Credit Union Scavenger Hunt game card or enter through the Woobox form (<https://woobox.com/htggk6>) are eligible to win. Game cards must be turned in at one of the below Ent Credit Union Service Centers during business hours or the drop box at Visit Fort Collins by 11:59 pm MT on Sunday, October 2, 2022 to count as an entry. Woobox form entries must be submitted by 11:59 pm MT on Sunday, October 2, 2022 to count as an entry.  
Service Centers:
    1. South College Service Center
    2. Shields Service Center
    3. North College Service Center
  2. Entrants must be at least 18 years of age.
  3. This sweepstakes is open to the general public, but credit union employees, officials and immediate family members are not eligible.
  4. No alternate entries will be accepted.
  5. By entering this sweepstakes, entrants accept and agree to be bound by these Official Rules and the decisions of the credit union.
  6. Sweepstakes void where prohibited by law.
  7. Entrants must possess a valid tax identification number, such as an SSN or ITIN for tax reporting purposes.
6. **Sweepstakes Winners:** There will be three (3) sweepstakes winners. Winners will receive one (1) prize package, valued at approximately \$1000 each. Please see the "Consumer Disclosure" section below for information regarding your odds of winning.
7. **Liability/General Rules:** The credit union is not responsible for any loss that may occur in connection with the sweepstakes. Entrant agrees to hold the credit union harmless from any liability arising from the participation in the sweepstakes or the acceptance, receipt, possession or misuse of the prize(s). The credit union and each of its officers, directors, employees, members, and representatives and agents are not responsible for any negligence, claims, liability, injury, property loss or other damages of the entrants and/or winners arising from, or in connection with, acceptance, receipt, possession, or use/misuse of prize awarded or participation in the sweepstakes. The credit union is not responsible for incorrect or inaccurate information, whether caused by tampering, hacking, or by any of the equipment or programming associated with the sweepstakes. Prize cannot be substituted, assigned or transferred by winner. The credit union reserves the right to substitute a prize of equal or greater value should the featured prize become

unavailable for any reason. The credit union reserves the right to disqualify entrants who fail to follow these Official Rules and regulations or who make any misrepresentations relative to the sweepstakes and redemption of prize.

8. **Collection of Awards:** Winner will be awarded one (1) prize package, valued at approximately \$1000 each. Winners will be contacted via phone and/or email about picking up their prize by Friday, October 7, 2022. Winner must claim prize by Friday, October 14, 2022.
9. **Tax Issues:** The credit union will report all prize winnings to the appropriate state and federal agencies as required by applicable law. Winners are responsible for all tax consequences (if any) of the prizes and will be required to furnish a taxpayer identification number prior to claiming any prize.
10. **Publicity Authorization:** The winner agrees to permit the credit union to utilize his/her name and likeness in promotional and other credit union materials without additional compensation or permission, except where prohibited by law. Each entrant authorizes Ent Credit Union to use any entry at the credit union's sole discretion for future advertisement or publication purposes and relinquishes all rights to any future compensation or remuneration based on such use.
11. **Arbitration:** Except where prohibited by law, as a condition of participating in this sweepstakes, entrant agrees that (1) any and all disputes and causes of action arising out of or connected with this sweepstakes or any prizes awarded, shall be resolved individually, without resorting to any form of class action, and exclusively, by final and binding arbitration under the rules of the American Arbitration Association ("AAA") and shall be held at the AAA regional office nearest the participant; (2) the Federal Arbitration Act shall govern the interpretation, enforcement, and all proceedings at such arbitration; and (3) judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim, punitive, incidental, or consequential damages, or any other damages, including attorney's fees, other than entrants' actual out-of-pocket expenses (i.e., cost associated with entering this sweepstakes), and entrant further waives all rights to have damages multiplied or increased.
12. **Choice of Law:** All issues and questions concerning the construction, validity, interpretation, and enforceability of these Official Rules, or the rights and obligations of entrant and the credit union in connection with the sweepstakes, shall be governed by, and construed in accordance with, the substantive laws of the state of Colorado, USA, without regard to choice of law rules.
13. **Consumer Disclosure:** Odds of winning are based upon the number of entries. Ent estimates odds of winning are 1 in 500.
