

**#ItsAnEntThing Social Media Sweepstakes
Official Rules**

1. **No purchase is necessary to enter or win the sweepstakes.**
2. Each sweepstakes entry will have an equal chance of winning. One winner eligible per giveaway.
3. Sponsor: Ent Credit Union (Ent) is the sponsor of the sweepstakes. The credit union's business address is 7250 Campus Drive, Colorado Springs, CO 80920.
4. Sweepstakes Period: Entries will be accepted from Friday, February 1, 2019 at 8:00 a.m. Mountain Time through Thursday, February 28, 2019 at 3:00 p.m. Mountain Time.
5. Eligibility:
 - a. To qualify for the sweepstakes, all entrants must be at least 13 years of age, "Like" or "Follow" the Ent Facebook and/or Instagram page and comment, tag or share as indicated on each contest post.
 - b. Credit union employees, officials and members of their immediate families are not eligible.
 - c. No alternate entries (those not submitted via Facebook or Instagram) will be accepted.
 - d. By entering this sweepstakes, entrants accept and agree to be bound by these Official Rules and the decisions of the credit union.
 - e. Sweepstakes void where prohibited by law.
 - f. Winners selected via "Random Number Generator" draw of comments on posts.
6. Sweepstakes Winners: One (1) prize package will be awarded every two (2) business day from February 1 through February 28.

7. Liability/General Rules: The credit union is not responsible for any loss that may occur in connection with the sweepstakes. Entrant agrees to hold the credit union harmless from any liability arising from the participation in the sweepstakes or the acceptance, receipt, possession or misuse of the prize(s). The credit union and each of its officers, directors, employees, members, representatives and agents are not responsible for any negligence, claims, liability, injury, death, property loss or other damages of the entrants and/or winners arising from or in connection with, acceptance, receipt, possession or use/misuse of prizes awarded or participation in the sweepstakes. The credit union is not responsible

for incorrect or inaccurate information, whether caused by tampering, hacking or by any of the equipment or programming associated with the sweepstakes. Prizes cannot be substituted, assigned or transferred by winners. The credit union reserves the right to substitute a prize of equal or greater value should the featured prize become unavailable for any reason. The credit union reserves the right to disqualify entrants who fail to follow these Official Rules and regulations or who make any misrepresentations relative to the sweepstakes and redemption of the prize.

8. Collection of Awards: Prizes will be awarded “on-site” from 7250 Campus Drive, Colorado Springs, Colorado 80920, or at a prearranged Ent Service Center location of the winner’s choosing. Ent is not responsible for loss of gift certificates. Winners must collect their prizes by March 29, 2019 or the prize will be forfeited and another winner will be selected.
9. Tax Issues: The credit union will report all prize winnings to the appropriate state and federal agencies as required by applicable law. Winners must provide their full name, address and social security number to collect their prize. Winners are responsible for all tax consequences (if any) of the prizes and will be required to furnish a taxpayer identification number prior to claiming any prize.
10. Publicity Authorization: The winner(s) agrees to permit the credit union to utilize his/her name and likeness in promotional and other credit union materials without additional compensation or permission, except where prohibited by law. Each entrant authorizes Ent Credit Union to use any entry in the credit union’s sole discretion for future advertisement or publication purposes and relinquishes all rights to any future compensation or remuneration based on such use.
11. Arbitration: Except where prohibited by law, as a condition of participating in this sweepstakes, entrant agrees that (1) any and all disputes and causes of action arising out of or connected with this sweepstakes or any prizes awarded, shall be resolved individually, without resorting to any form of class action, and exclusively, by final and binding arbitration under the rules of the American Arbitration Association (“AAA”) and shall be held at the AAA regional office nearest the participant; (2) the Federal Arbitration Act shall govern the interpretation, enforcement, and all proceedings at such arbitration; and (3) judgment upon such arbitration award may be entered in any court having jurisdiction. Under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental, or consequential damages, or any other damages, including attorney’s fees, other than entrants’ actual out-of-pocket expenses (i.e., cost associated with entering this sweepstakes), and entrant further waives all rights to have damages multiplied or increased.
12. Choice of Law: All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of entrant and the credit union in connection with the sweepstakes, shall be governed by, and construed in accordance with, the substantive laws of the state of Colorado, USA, without regard to choice of law rules.
13. Consumer Disclosure: Odds of winning are based upon the number of entries per sweepstakes. Estimated odds of winning are 1 in 11,812.
